Wedding Policies

Room Minimums and Charges:

There is a \$1,000.00 Flat Room Rental Fee when using one of the above reception wedding packages. Rooms are reserved on a 5-hour time allotment. An additional \$350.00 per hour room rental will apply to any additional hours added. This pricing does not include ceremony fees.

Food and Beverage:

Menu selections must be submitted to the Catering office no later than 45 days prior to the scheduled function. Guarantee of exact attendance for all banquet facilities must be made 30 days in advance. The guaranteed guest number cannot be reduced. Minimum charge of 100% guaranteed guest number. If the Catering office receives no guarantee, Crescent Farms will assume the guarantee to be the original number reserved. No food and beverage of any kind will be brought onto the premises, except for the wedding cake or candy. A 21% service charge and state sales tax will be added to all food and beverage items. Menus and pricing are subject to change on an annual basis.

Termination for Cause:

This agreement is subject to termination without liability upon the occurrence of any circumstance beyond control of either party—such as acts of God, war, acts of terrorism, government regulations, disaster, strikes, civil disorder, curtailment of transportation facilities or any emergency of a comparable nature beyond the parties control, making it impossible, illegal, or which affects a party's ability to perform it's obligations under this contract—to the extent that such circumstances make it illegal or impossible to provide or use the Club facilities.

General Conditions:

The Club does not permit nails, staples, tacks, etc. to be used on the meeting room walls and or tables. Any damage will be billed to the host. Crescent Farms Golf Club reserves the right to inspect and control all private meetings and receptions held in the Club. Crescent Farms Golf Club will not assume responsibility for the damage or loss of any merchandise or articles left in the club prior to, during, or following your function.

Wedding Policies

General Conditions (Continued)

Liquor sales are governed by state laws and are strictly followed. Any violation of Missouri State Liquor Laws by a minor will result in the notification of the correct authorities. Crescent Farms Golf Club also reserves the right to refuse service to a guest at discretion of Crescent Farms Golf Club staff. Crescent Farms Golf Club reserves the right to move a party to another room or charge a fee for the room, depending on the guaranteed number of people in the party.

Rental and fees:

Meal service periods include use of room and service personnel for that period.

Lunch: 4 Hour Maximum

Dinner: 5 Hour Maximum

If an additional meeting room or time is required beyond the time stated above, there will be an additional \$350.00 per hour minimum charge.

- **Bartender charge for additional bartender (required at 100+ guests).....\$100.00**
- **Front Circle Ceremony Fee: \$500.00 or Hole #1 Fee: \$1,000.00 (must rent chairs also)**
Ceremonies are only allowed after 3:00pm, no exceptions.
- **White chairs are an additional charge at \$2.00/chair.**
- **Additional 90" Round tables are \$15.00/table.**
- **There is a \$40.00 delivery charge for all chair and table deliveries.**

Deposits and Payment

Crescent Farms Golf Club accepts cash, cashier checks, personal checks, MasterCard, Visa and Discover. Crescent Farms Golf Club requires a deposit of \$1,000.00 to hold the date of your requested event. All events must be paid in full 15 days prior to event. A 3% service charge will be charged on all credit card transactions.
